OVERVIEW REGARDING COVID-19 TRIAL PRECAUTIONS

The Merrimac Dog Training Club is excited to provide the opportunity for Obedience and Rally enthusiasts to compete in this organized trial, but our continued priority is the safety and well being of all involved. In order to achieve this, all participants must agree to abide by the established COVID-19 guidelines, so we may look out for one another and ensure that the trial environment is as safe as possible.

Should you be unable or unwilling to adhere to these guidelines, please do not enter these trials, and instead consider joining in on a different future trial/event, post-pandemic...thank you.

****All safety guidelines below apply regardless of an individual's vaccination status and/or any future changes to state/local government health orders.****

These guidelines align with CDC and VDH recommendations, and include:

- Properly wearing (fully covering mouth and nose) appropriate face-coverings (masks) at all times when inside the trial building – including while exhibiting in the show ring.
- Maintaining six feet of physical distance and avoid congregating.
- Adhering to the limit on building capacity.

In addition, the following best practices, per AKC recommendations, will be in place:

- ❖ Exhibitors entering trial will be required to sign the included COVID-19 Waiver of Liability with their entry (page 7 of this Premium). In addition to submitting the waiver with entry forms/fee, exhibitors must have the waiver submitted/approved AGAIN, before picking up an armband the day of the trial.
- ❖ Masks must be worn upon entering the building, and remain properly on (covering nose and mouth) until exiting the building. Our volunteers and judges will be properly wearing masks, as well.
- ❖ The trial will be held indoors. In addition, separate clearly marked entrance and exit doors will be used and building capacity will be limited.
- ❖ Limited crating will be available in the building. No chairs will be provided. Crating in vehicles or outdoors on the lawn is encouraged.
- ❖ Judging classes will be staggered in time blocks, and participants should arrive no sooner than 60 minutes prior to their scheduled start time, and leave upon the conclusion of their class(es).
- ❖ There will be multiple walkthrough groups for classes with large entries.
- ❖ These trials will be closed to the general public and other spectators, and exhibitors should leave the building when finished showing.
- ❖ See pages 5, 6, & 7 for additional safety procedures and precautions that will be in place at this trial to mitigate the spread of COVID-19.

ADDITIONAL ENTRY / EXHIBITOR NOTES

Jump Height must be indicated on all entries for classes requiring jumps.

Entries w/o full fees or w/o included waiver will not be accepted.

Acknowledgement of entries will be made as soon as practical. If not acknowledged within reasonable time, contact the Trial Secretary via email.

Entries not on official included AKC entry forms and/or copies of entry forms without the Agreement/Rules included or with any amendments made are not acceptable.

Unsigned or illegible entries will not be accepted.

Returned checks do not constitute a valid entry, and a \$25 fee will be added for each returned check.

No refunds will be issued for overpayment of fees if error is < \$10.

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a Vet or Judge, or barred from competition by action of the Trial Committee. Nor due to the cancellation/stop of the trial show due to any sort of civil disturbance, severe weather event, or other unpredicted situation beyond our control.

Owners are responsible for errors in making out entry forms and no refunds will be made if errors are not acknowledged before the published closing date.

All Dogs Present must be held on leash or confined to their crates except when being judged in the ring.

Bitches in Season: Females in season are not permitted to compete. If a female is withdrawn because it came into season, the entry fees will be refunded. To be eligible for such refund, the Show Secretary must be notified in writing, no later than one half hour prior to the start of the first class in the trial. A veterinarian's certificate confirming the fact that the bitch is in season must also be presented.

The Judge is Not Required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required.

Move-ups/Transfers are welcome. Transfer forms may be submitted to the Trial Secretary by mail or e-mail no later than Monday, June 14. Transfer forms may be provided to the Trial Secretary on the day of trial, 30 minutes before the start of each trial. Transfer forms resulting from titles earned in Obedience Trial 1 may be submitted to the Trial Secretary as soon as possible.

The Trial Committee/Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show. By entering these trials, the exhibitor has indicated acceptance of the terms listed in this premium list and assumes all risks involved.

Go approximately 0.6 miles, and take a right on Newsome Place. Proceed to the end of the short road, and the yellow building will be on the right.

From I-64 East or West - Take the 664 Exit, then take Exit 2 toward Powhatan Parkway/Power Plant Parkway, and take a left at the end of the exit ramp. Take the second left turn lane onto Salters Creek Rd. Go approximately 0.6 miles, and take a right on Newsome Place. Proceed to the end of the short road, and the yellow building will be on the right.

COVID-19 Precautions Details - MDTC Trial Plan

[Adapted from GSDCGW for AKC Obedience/Rally Trials]

Date(s) of Trial(s): June 18th - 20th, 2021

Upon publication of this premium, MDTC is following the State of Virginia's fourth amended Executive Order Seventy-Two and Order of Public Health Emergency Nine, with respect to the COVID-19 pandemic. This includes a universal mask mandate and limit of 50 at indoor gatherings. ***All COVID-19 precautions outlined in this premium will continue to be upheld, even if state/locality expectations lessen come the dates of the trial.***

Any person who fails to follow this Plan may result in dismissal from this event – thank you for working collaboratively to keep everybody well, and permit all to safely enjoy this opportunity to exhibit.

1. WHEN TO STAY HOME – You should NOT attend the trial if you cannot or will not adhere to the COVID-19 precautions, and/or if you cannot confidently answer YES to the following primary questions on the waiver, which you will be asked to turn in on the day of the trial:

- I certify that I do not, to my knowledge, have COVID-19 at the time of attending this Event. Nor have I been in contact with or exposed to any known carrier of COVID-19 within the past 14 days prior to the Event. Nor have I been at any large event gathering where proper social distancing and masks were not enforced within the last 14 days.
- I also state that I am at the present time free of symptoms of such infection including: FEVER, COUGH, SHORTNESS OF BREATH, AND/OR PERSISTENT PAIN/ PRESSURE IN THE CHEST.
- If I have had the virus, I certify that I have had at least two negative tests 14 or more days prior to the Event or have had a positive antibody test, and have been released by government officials and/or health care providers to resume normal activity without limit.

If entered and unable to attend due to changes to the above, please email the trial secretary and you'll be refunded 50% of your entry fee. Anyone who attends a public gathering must recognize there remains a certain level of risk associated with contracting COVID-19, despite precautions taken to reduce that risk.

2. FACE MASKS – will be required of EVERYONE AT ALL TIMES while in the building, including while exhibiting in the ring. Your mask must cover your nose, mouth, and chin. Please bring extra masks with you (MDTC will not be providing masks).

While outside the building (i.e. in the parking lot), a mask is not required provided you maintain a 6-ft distance from others.

3. RING SETUP – we will be conducting a one-ring trial. Exhibitors will be asked to leave the premises at the conclusion of their final class.

4. NO SPECTATORS will be permitted at these trials or on the show grounds. If an exhibitor requires an assistant, the assistant will be allowed access to the building after signing the COVID-19 waiver at the check-in table.

5. NO CHILDREN under 18 will be permitted at these trials or on the show grounds unless showing a dog.

6. DOG OUTSIDE AREA – Dogs must be on leash at all times, both inside and outside the building, except when being shown in the ring. Please pick up after your dog and dispose of dog waste in the receptacles located around the outside of the building.

7. CHECK-IN PROCESS – There will be a check-in table by the main entrance of the building. You are required to check-in prior to entering the building and may not check-in earlier than 60 minutes before the start of your first class. During check-in you will sign/turn in the COVID-19 waiver, receive your armband for your class(es), and receive instructions for navigating the building. **Please check in WITHOUT your dog.** Maintain six-foot distance from the check-in steward and others in line.

8. CRATING – indoor crating space will be limited. Exhibitors may begin crate set up 60 minutes prior to the start of their class. When your class(es) has finished and the awards announced, you will be expected to leave the premises. All personal items (including crates/chairs) are to be removed from the building each day, even if you are competing the following day.

9. BUILDING ENTRANCE, EXIT AND HAND HYGIENE – every time you enter the building, you are required to wash your hands in the designated restroom or use club-provided hand sanitizer. We will make every effort to have several hand sanitizing stations inside the arena area. Please plan to bring your own hand sanitizer, as well. Please follow signs indicating the entrance and exit paths within the building.

10. CLASS STAGING - The Judge / Steward will communicate where the exhibitor will stand and provide instructions on what to do with articles, gloves, dumbbells and leash. Be sure to remain at least 6ft from the steward's table, the ring entry, and the dog leaving. Please avoid congregating in any spaces throughout and around the trial building site.

11. PERSONAL CHAIRS will only be allowed in your crating area, and the

club will not provide any chairs. Chairs may not be set up at ringside.

12. CLASS AWARDS - At the conclusion of each class, the judge will announce the placements/qualifiers. Exhibitors will not return to the ring to receive their awards. Rosettes and qualifying ribbons will be available for pickup in a designated area apart from the ring.

13. LUNCH - will be on your own for all exhibitors. No food or beverages (other than water) are allowed to be consumed by humans within the building.

14. SANITIZING AND CLEANING - Door handles, equipment, and common surfaces will be wiped down periodically throughout the trial and at the end of each day.

15. TRIAL CANCELLATION - MDTC reserves the right to cancel this trial at any time. Should that happen, any checks for trial entry fees will be shredded.

16. WAIVER - The Waiver of Liability (page 7) will be required to be submitted via mail with an exhibitor's entry AND again signed and submitted the day of the trial.

17. UPDATES TO PLAN - Updates and changes to tighten this plan will be made, as needed, as we continue to monitor the state of COVID-19. Updates will be emailed to all exhibitors.
